

FFC Frozen Semen Contract

This **contract** entered into on (date) _____, is by and between owner, **VANESSA MORGAN** or agent, **Amethyst Acres**, hereinafter designated **Seller**, and the **Buyer/Breeder** (print name) _____, hereinafter designated **Buyer**. Seller is owner or agent of this frozen semen and has legal right to sell the same.

Seller agrees to provide Buyer _____ doses of frozen semen at \$500 each for breeding the above mentioned mare. Each dose of frozen semen is defined as one (1) straw containing one (1) billion sperm cells collected from the Connemara stallion **Balmullo's Beacon (ACPS# S545XXXI)**.

PURCHASER MUST NOTIFY AMETHYST ACRES WITH A MINIMUM OF 48 HOURS NOTICE PRIOR TO SHIPMENT OF FROZEN SEMEN, PREFERABLY A WEEK OR TWO IN ADVANCE OF NEED.

1. All shipment of frozen semen must be paid for by Buyer before semen is shipped.
2. Buyer is responsible for all costs of charging and shipping the frozen semen vapor shipper.
3. Buyer agrees to return the tank via prepaid Federal Express within 24 hours of its receipt, along with signed form acknowledging receipt of transported semen. If tank is not shipped for return within 24 hours, Buyer agrees to pay a \$30 per day delinquent fee until tank is returned.
4. Any loss or damage to the tank after arrival will be the responsibility of the Buyer, up to the sum of \$750.00; thus, we advise that when you return it to Amethyst Acres, it is insured prior to mailing/shipping for protection against the carrier's loss.
5. Buyer takes all responsibility for any damage, loss or injury resulting from the handling of the vapor shipper and its contents.
6. A Certificate for Transported Semen (see attached) will be sent with each semen shipment and must be filled out by the inseminating Veterinarian. One (1) copy must be returned to Seller upon insemination. *Failure to do so may delay registration of the foal indefinitely.*
7. Buyer must contact Seller within 30 days post insemination to confirm that the mare has been settled successfully in foal or to order additional breeding doses, if so desired.
8. Additional mares may be bred from this semen purchase under this contract only upon written approval from Seller and compliance to appropriate sections of this contract.
9. Buyer agrees to register the resulting foal with the ACPS and to notify Foothills Farms Connemaras of the color, gender and birth date of the foal. *Please try to notify Foothills Farms within 5 days of your foal's birth.* Upon such notification, a "Registration Application" (required for registering the foal with the ACPS) will be issued to the Buyer for the foal, conceived by this mating, provided that the Certificate of Transported Semen was properly returned to Seller. It is the Buyer's responsibility to obtain and complete any breed association paperwork and for any fees required for registration and inspection.
10. This contract may not be assigned or transferred by Purchaser.
11. This contract, signed by respective parties, and those documents referred to herein, which are hereby incorporated by reference, constitutes the entire agreement by the Seller and Buyer and same may not be amended or modified.
12. This contract shall be interpreted in accordance with the State of Tennessee, and its validity and administration shall be governed by said laws. In the event of breach of this contract, or any part thereof, Buyer agrees to pay any and all reasonable attorney's fees or other expenses incurred, or which may be incurred by or on behalf of the Seller in the enforcement of this agreement.
13. For optimal results, the mare should be bred as close to ovulation as possible with a clean uterus, having no disease or infections. Specific instructions regarding application of the frozen semen straws will be provided when shipped. However, frozen semen offers no live foal guarantee. If you or your Veterinarian has any questions, contact Mark Burke at Amethyst Acres Equine Center, Inc. at 540-254-1017.
